Mr Clough exclusively specialises in ankle & foot surgery and sports injuries. He gained extensive experience in these areas throughout his training and with an International Sports Medicine and Arthroscopy Fellowship in Canada. During his training he won both the Sanofi Synthelabo Travelling Fellowship prize and the British Orthopaedic Foot Surgery Society Travelling Fellowship Prize. He has published articles on ankle, knee and big toe joint replacement surgery, daycase forefoot surgery and the role of PRP in plantar fasciitis. He regularly presents as Faculty Member at regional, national and international meetings. He sits on the Research and Development Committee at Wrightington. He is PROMS (Patient Related Outcome Measure Score)

Lead for his NHS Trust in foot and ankle and has attracted Wrightington Hospital to be one of the few hospitals piloting the PROMS National Project.

He has been Chairman of Faculty for the Foot & Ankle module for an MSc in Sports Orthopaedics at the University of Salford and an Honorary Senior Lecturer at the University. He has served as External Examiner for the School of Medicine BSc programme at the University of Dundee.
