Commercial Office Development - JCT D&B, Scotland

Instructed as Quantum Expert to provide three expert reports in litigation, dealing with project wide defects and assessment of variations requiring opening up and reinstatement works, including fire protection to exposed beams and consideration of standards in the transition during BSA enactment. Working alongside technical and delay experts to align quantum with issues of liability. Forensic review of records and costs and provision of several scenarios to assist the courts in allocating costs. Earthworks Remediation Scheme in England

Instructed as Expert in Quantity Surveying and NEC3 Project Manager to consider whether the Project Manager had negligently over-certified sums to a Contractor, before entering liquidation. The project included excavation, treatment and placement of over 5 million m³ of material, categorised as primary, secondary and contaminated sludge varieties. The material was deposited into environmental bunds, plots and recreational areas, alongside drainage, access roads and fill plateaux's for building construction. My quantum assessment included identification of baseline and actual quantities, methods of recording mass haul, treatment and placement of materials across numerous data sets to determine likely quantities completed. Heads of claim included a significant finance contribution, defects and fees. Amount in dispute was >£25m. *Solicitor: Eversheds Sutherland.*

Flood Alleviation Scheme in Scotland

Instructed as Quantum Expert for a Contractor under an NEC4 Option A project, concerning the construction of flood alleviation infrastructure, including a dam, spillway, headwalls, retaining structures, fish lock, attenuation and creation of flood plains. The project was subject to level and technical changes, resulting in increased costs and delays for which the contractor sought recompense. I provided a series of expert reports in adjudication to

Major New Port- FIDIC, England

Review of extensive claims up to £20m from supply chain in relation to enhancement and delay to civils design, including sheet pile quay wall and capping beam, earthworks and surcharge settlement, large diameter drainage and access roads.
